Diaper Ordering Do's and Don'ts Tips for getting the EHS diapers you need

- Check your classrooms before placing an order and submit your order on a need-only basis by the 15th of each month. Popular sizes are three, four, five, and six.
- Order your diapers based on the number of children in your program. (example: five slots equal five boxes of diapers.) Each box has about 100 diapers.



- Deliveries should occur within 48-72 hours after the order has been placed.
- If you have a family that needs diapers at home, direct them to their Family Specialist for assistance. EHS diapers are for use during classroom hours.
- 5. If you have a child with a confirmed allergy to Pampers let your Family Specialist know and send your specific diaper request to Michelle.

- You have an excess of unopened packages in sizes you don't need
- You are out of diapers and wipes
- You are not receiving your orders on time



Had a baby in 2020 or 2021?

You could get up to \$5,000 in federal money for your baby. (\$3600 with the **Child Tax Credit plus a** \$1400 stimulus payment)





Policy

- You could also get other payments for yourself and any other children you have.
- You can get this money even if you have never done taxes before or if you have not in the last few years.
- This money does not count for most benefits, like SNAP, WIC, TANF, MEDICAID, CHIP, SSI, Emergency Assistance shelter, and most types of public and subsidized housing
- If you didn't get the 2020 stimulus payments for a baby born in 2020 (\$500 for the first payment and \$600 for the second), you can get these by filing a late or amended 2020 tax return.

Child Care Manual Procedure Letter No. 159

TO: All Child Care Manual Holders

SUBJECT: Update to the JFS 08087 Communicable Disease Chart

Background:

The Ohio Department of Health (ODH) recently revised their guidelines to protect against COVID-19 in child care and educational settings. As a result, the prescribed form JFS 08087 "Communicable Disease Chart" has been updated to amend the response guidelines for COVID-19 (SARS-CoV-2). Per Chapters 5101:2-12, 5101:2-13 and 5101:2-18 of the Ohio Administrative Code, the JFS 08087 must be posted in the child care center, family child care home and approved day camp.

New Guidelines for COVID-19 (SARS-CoV-2) as stated on the JFS 08087: EXCLUSION

Children and staff with a positive test or signs and symptoms consistent with COVID-19 shall be excluded until criteria to discontinue isolation has been met. QUARANTINE

Quarantine at home may be recommended for close contacts of someone diagnosed with COVID-19, depending on vaccination status and previous disease history. CONTROL

Encourage vaccination of eligible persons, unless contraindicated. Isolate children who begin to show symptoms while in the building away from others when possible, in an isolation room if available. Recommended prevention measures include adequate ventilation, modifying spaces to allow better distancing, handwashing, covering coughs and sneezes, and cleaning and disinfection (EPA List N). Additional measures (e.g., masking, physical distancing, cohorting, etc.) may be recommended under certain situations. Your child care program or school might need to implement additional procedures if an outbreak occurs. If an outbreak is suspected, work with your local health department to determine next steps. REPORTING

Report to the local health department as described in the Ohio Department of Health's Infectious Disease Control Manual: https://odh.ohio.gov/know-our-programs/infectious-disease-control-manual/section3/section-3-coronavirus-disease-2019. Vaccine available. Please check with local health department regarding eligibility guidelines.

Implementation:

Programs will not be required to order the revised chart. Programs must print this procedure letter and post it next to the chart to meet compliance with the Ohio Administrative Code. Programs may order a new chart once they become available in the warehouse.
